## 1 Policy at a glance

### 1.1 Key Points:

- **Purpose:** To establish a comprehensive Personal, Social, Health Education (PSHE) policy that aligns with statutory requirements and promotes the well-being and development of students;
- **Designated Teacher:** Ensures a dedicated staff member supports the educational needs of looked-after and previously looked-after children;
- **Curriculum:** The policy outlines a broad and balanced curriculum that meets the needs of all students, including those in care;
- **PSHE Approach:** The school uses a whole-school approach, employing the Jigsaw Programme to provide a structured and comprehensive PSHE curriculum;
- **Relationships and Health Education:** The policy covers both statutory Relationships Education and Health Education, emphasising the importance of healthy, respectful relationships and overall well-being;
- **Sex Education:** While not mandatory in primary schools, the policy addresses sex education as part of human reproduction and provides parents with the right to request withdrawal from these specific lessons;
- **Monitoring and Review:** The policy includes regular monitoring and review by the Local Governing Body to ensure its effectiveness and alignment with statutory requirements;
- **Equality:** The policy emphasises equality and respect for all students, including those from diverse backgrounds.

1.2 Overall, the policy aims to create a supportive and inclusive learning environment that fosters the personal, social, and academic development of all student

## 2 Introduction

Prior to final approval by the LGB, this policy has been the subject of review and suggested amendments have been taken into consideration and changes made where they can be agreed.

## 3 Context

- All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under Section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum;
- Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and;
- Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

## 4 PSHE

4.1 At Chiltern Primary School we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

- 4.2 The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children’s learning in this vital curriculum area.
- 4.3 The overview of the programme can be seen on the school website.
- 4.4 This also supports the “Personal Development” and “Behaviour and Attitudes” aspects required under the Ofsted Inspection Framework, as well as significantly contributing to the school’s Safeguarding and Equality Duties, the Government’s British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

## 5 Statutory Relationships and Health Education

- 5.1 “The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education... They also make Health Education compulsory in all schools except independent schools. Personal, Social, Health and Economic Education (PSHE) continues to be compulsory in independent schools.” DfE Guidance p8
- 5.2 “Today’s children and young people are growing up in an increasingly complex world and living their lives seamlessly on and offline. This presents many positive and exciting opportunities, but also challenges and risks. In this environment, children and young people need to know how to be safe and healthy, and how to manage their academic, personal and social lives in a positive way.”
- 5.3 “This is why we have made Relationships Education compulsory in all primary schools in England... as well as making Health Education compulsory in all state-funded schools.”
- 5.4 “In primary schools, we want the subjects to put in place the key building blocks of healthy, respectful relationships, focusing on family and friendships, in all contexts, including online. This will sit alongside the essential understanding of how to be healthy.”
- 5.5 “These subjects represent a huge opportunity to help our children and young people develop. The knowledge and attributes gained will support their own, and others’ wellbeing and attainment and help young people to become successful and happy adults who make a meaningful contribution to society” Secretary of State Foreword DfE Guidance p4-5
- 5.6 “Schools are free to determine how to deliver the content set out in the DfE guidance 2019 in the context of a broad and balanced curriculum. Effective teaching in these subjects will ensure that core knowledge is broken down into units of manageable size and communicated clearly to pupils, in a carefully sequenced way, within a planned programme of lessons.” DfE Guidance p8
- 5.7 “All schools must have in place a written policy for Relationships Education and RSE” DfE Guidance p11

- 5.8 Here, at Chiltern Primary School we value PSHE as one way to support children’s development as human beings, to enable them to understand and respect who they are, to empower them with a voice and to equip them for life and learning.
- 5.9 We include the statutory Relationships and Health Education within our whole-school PSHE Programme.
- 5.10 To ensure progression and a spiral curriculum, we use Jigsaw 3-11, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to your children’s needs. The Jigsaw mapping document at page 10-16 of this policy and statutory Relationships and Health Education, shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.
- 5.11 This programme’s complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

- 5.13 The Jigsaw Programme is aligned to the PSHE Association Programmes of Study for PSHE.

## 6 What do we teach, when and who teaches it?

### 6.1 Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

Term	Puzzle (Unit)	Content
Autumn 1:	Being Me in My World	Includes understanding my own identity and how I fit well in the class, school and global community. Jigsaw Charter established.
Autumn 2:	Celebrating Difference	Includes anti-bullying (cyber and homophobic bullying included) and understanding
Spring 1:	Dreams and Goals	Includes goal-setting, aspirations, who do I want to become and what would I like to do for work and to contribute to society
Spring 2:	Healthy Me	Includes drugs and alcohol education, self-esteem and confidence as well as healthy lifestyle choices, sleep, nutrition, rest and exercise
Summer 1:	Relationships	Includes understanding friendship, family and other relationships, conflict resolution and communication skills, bereavement and loss
Summer 2:	Changing Me	Includes Relationships and Sex Education in the context of coping positively with change

6.2 At Chiltern Primary School we allocate at least one session to PSHE each week in order to teach the knowledge and skills in a developmental and age-appropriate way.

6.3 These explicit lessons are reinforced and enhanced in many ways including:

- Assemblies and collective worship, praise and reward systems, Learning Charter, through relationships child to child, adult to child and adult to adult across the school. We aim to 'live' what is learnt and apply it to everyday situations in the school community;
- Class teachers and teaching assistants deliver the weekly lessons to their own classes.

## 7 Relationships Education

7.1 ***What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?***

7.2 Relationships Education in primary schools will cover 'Families and People Who Care For Me', 'Caring Friendships', 'Respectful Relationships', 'Online Relationships', and 'Being Safe'.

7.3 The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the Jigsaw mapping document and Statutory Relationships and Health Education.

7.4 It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

## 8 Health Education

8.1 ***What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?***

8.2 Health Education in primary schools will cover 'Mental Wellbeing', 'Internet Safety and Harms', 'Physical Health and Fitness', 'Healthy Eating', 'Drugs, Alcohol and Tobacco', 'Health and Prevention', 'Basic First Aid', 'Changing Adolescent Body'.

8.3 The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the Jigsaw mapping document and Statutory Relationships and Health Education.

8.4 It is important to explain that whilst the Healthy Me Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm Me Time, social skills are grown every lesson through the Connect Us activity and respect is enhanced through the use of the Jigsaw Charter.

8.5 Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing Adolescent Body' strand, and in Jigsaw this is taught as part of the Changing Me Puzzle (unit).

8.6 Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

## 9 Sex Education

9.1 The DfE Guidance 2019 recommends that all primary schools 'have a sex education programme tailored to the age and the physical and emotional maturity of the pupils' p23

9.2 However, 'Sex Education is not compulsory in primary schools' p23

9.3 Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and - drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

- 9.4 At Chiltern Primary School, we believe children should understand the facts about human reproduction before they leave primary school.
- 9.5 We define Sex Education as understanding human reproduction.
- 9.6 We intend to teach this as part of the PSHE curriculum.

## 10 Parents' right to request their child be excused from Sex Education

- 10.1 "Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education" DfE Guidance p17
- 10.2 At Chiltern Primary School, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle (unit). We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this i.e. the Jigsaw Changing Me Puzzle (unit) e.g.
- Year 4, Lesson 2 (Having a Baby)
  - Year 5, Lesson 4 (Conception)
  - Year 6, Lesson 4 (Conception, Birth)
- 10.3 The school will inform parents of this right by letter prior to the delivery of these sessions.

## 11 Monitoring and Review

The Local Governing Body (LGB) monitors this policy on an annual basis. The LGB gives serious consideration to any comments from parents about the PSHE programme and makes a record of all such comments. Teaching materials are scrutinised and ratified to check they are in accordance with the school's ethos.

## 12 Equality

- 12.1 **This policy will inform the school's Equalities Plan.**
- 12.2 The DfE Guidance 2019 (p15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics"
- 12.3 At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender) they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum.



12.4 At Chiltern Primary School we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

12.5 For further explanation as to how we approach LGBT relationships in the PSHE (RSHE) Programme please see: 'Including and valuing all children. What does Jigsaw teach about LGBTQ relationships?'

### 13 Public Sector Equality Duty

13.1 The Equality Act 2010 replaced and unified all existing equality legislation such as the Race Relations Act, Disability Discrimination Act and Sex Discrimination Act. It aims to ensure that people have equality of opportunity in accessing and experiencing public services. Schools when carrying out their day to day work should have regard to the following:

- eliminating discrimination;
- advancing equality of opportunity
- fostering good relations across all characteristics

13.2 Schools cannot unlawfully discriminate against pupils because of their disability, gender, race, religion or belief, sex and sexual orientation. Protection is now extended to pupils who are pregnant or undergoing gender reassignment. This means it is now unlawful to discriminate against a transgender pupil.

13.3 This policy was reviewed and updated with reference to this duty. The author/s of this document considered this policy in the light of these requirements to ensure that Chiltern Primary School adheres to these statutory regulations.

## Guidance - Relationships Education in Primary schools – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults.

The guidance states that, by the end of primary school:

## Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
